To Find Ethics Opinions

The ABA and state professional responsibility boards issue *ethics opinions*, advisory opinions attorneys request to determine acceptable conduct under the ethics rules. Formal ethics opinions focus on matters of general interest to the bar while informal ethics opinions focus on specific factual situations.

To Find Disciplinary Actions

State professional responsibility boards also issue *disciplinary actions*, such as reprimands, suspensions, or license revocations, against attorneys who violate the ethics rules. Attorney disciplinary actions are usually published in the state bar journals, shelved alphabetically on the first floor of the Law Library in the KF 200s. Unfortunately, disciplinary actions are rarely indexed, which hinders research.

Many states provide access to disciplinary actions through the state bar association web pages or the state judicial web pages. For example, check out Iowa's Search for Disciplinary and Disability Orders at <u>https://www.iacourtcommissions.org/icc/SearchDiscipline.do</u>. The American Bar Association provides a gateway to state disciplinary commissions at <u>http://www.abanet.org/cpr/regulation/directory.pdf</u>. You will have to explore linked pages, however, to locate the disciplinary actions within the sites.

To Find Court Cases Involving Ethics

Courts often decide cases involving ethical issues, such as malpractice and ineffective assistance of counsel. To aid individuals researching ethical issues, Westlaw and Lexis have created separate databases of the court cases involving ethics. The phrase "ethics cases" refers both to these special databases and to the cases contained within these databases.
